

Scene in San Francisco DISCOUNT CARD PROGRAM VENDOR GUIDELINES



The San Francisco Film Office, part of the Mayor's Office, is proud to unveil the **Scene in San Francisco Discount Card Program**. By becoming a participating Scene in San Francisco vendor, your business will be listed **free of charge** on the Film Office's website (<u>http://filmsf.org/</u>) and will gain access to film and television productions that shoot in San Francisco—all of which bring millions of dollars per year in total revenue to the City and vendors like you.

Providing a discount is a requirement to become a participating vendor in the Scene in San Francisco Program. Scene in San Francisco vendors may choose to offer discounts to **both** production companies filming in San Francisco and to individual crew members working on those productions. (For example, a dry-cleaning business might offer a 10% discount to crew members who clean their individual items, but a 25% discount to a production company that launders more than 50 items at a time.)

*Vendors must provide minimum discounts consistently to all holders of the Scene in San Francisco card.

*Discounts must be **quantifiable**.

*For businesses other than restaurants: a minimum discount of 10% off goods & services must be offered.

*For restaurants: offer must provide the equivalent added value of <u>one course or one beverage</u>.

In addition, it would be very helpful to the Film Office if your business could periodically report the amount of revenue that it has generated due to participation in the Program. The Film Office will use this information to evaluate the success of the program and to justify the need for increased incentives to draw more film production—and the resulting revenue—to San Francisco. Every 6 months the Film Office will send you a form to make this reporting process easier.
