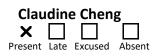
1. SAN FRANCISCO FILM COMMISSION LAND ACKNOWLEDGEMENT (04:03)

The San Francisco Film Commission and Film SF staff acknowledges that we are on the unceded ancestral homeland of the Ramaytush Ohlone who are the original inhabitants of the San Francisco Peninsula.
